## Are you "Sandwiched"?

Australia's Baby Boomers have become our nation's carers

- financially, practically and emotionally.

The term 'sandwich generation' refers to the Baby Boomers who married and had children later than their forebears and have become the "first modern generation" to be sandwiched between the care of adult children and their own parents. More than a fifth of household are multigenerational, comprising two or more generations of related adults aged 18 or over.2

Only one in 10 of the older generation lives in a retirement village. That means the rest are living in their own place of residence, but maintaining independence with the help of their kids. These "kids" (most often in the late 40s, 50s and 60s) are the ones taking their parents to the doctor or arranging for a plumber to visit.

Data from last year's census showed about 21 per cent of families have adult children who are living at home, up from 20 per cent in 2006. The largest increase was recorded for sole-parent families with children aged 18 or

over, which jumped 17 per cent to 385,078 families. Couples with at least one child over 18 living at home rose 7.5 per cent.

For those who are 'sandwiched', and with so much riding on you, it's important to consider the personal protection strategies you need should you take ill or have an accident that prevents you from earning and providing the financial support you need, not just for yourself but for your parents and adult children as well.




